On March 24, 2022, respondent filed a Verified Second Supplement to Response to Petition. Attached to the Second Supplement as Exhibit E is an accounting for the time period of January 1, 2021, through December 31, 2021. The Second Supplement was served by mail on petitioner, via his attorney, on March 22, 2022. To date, petitioner has not filed a written response regarding the Second Supplement.

Given that respondent resigned as trustee and a successor trustee was appointed, and given that respondent provided an accounting through December 31, 2021, she requests that the petition be dismissed as all of petitioner's concerns have been addressed.

Although, to date, petitioner has not responded or objected to the status report, the accounting, or respondent's request to dismiss the petition, objections can be made at any time, even orally at the hearing. (Prob. Code § 1043.) Therefore, appearances are required.
