**1. AMANDA RENFROE V. ANDREW RENFROW**

On January 30, 2023, the parties submitted a stipulation and order, which the court signed and adopted as its order. The stipulation included a provision for a rereferral to Child Custody Recommending Counseling (CCRC) for an appointment on March 6, 2023 and a review hearing on April 27, 2023.

The parties attended CCRC on March 6, 2023 and were unable to reach any agreements. A report with recommendations was filed on April 12, 2023. Copies were mailed to the parties the same day.

The court has read and considered the CCRC report and finds the recommendations as set forth in the report to be in the best interests of the minors. The court adopts the recommendations as its orders with the following modification. The court does not adopt the provision for drug testing as set forth on page ten beginning at line four. Rather the court is maintaining the prior orders for drug testing as set forth in the parties' stipulation of January 30, 2023. The court is adding the following provision, if Respondent has complied with the email notice provision to Petitioner's counsel which includes the reason for the requested test, and Petitioner fails to test, the test will be considered a positive test. The court is adopting the abstention orders as set forth beginning on page ten line eight. The court is adopting the remaining recommendations without further modification.

All prior orders not in conflict with this order remain in full force and effect. Petitioner shall prepare and file the Findings and Orders After Hearing.

**TENTATIVE RULING #1: THE COURT FINDS THE RECOMMENDATIONS AS SET FORTH IN THE REPORT TO BE IN THE BEST INTERESTS OF THE MINORS. THE COURT ADOPTS THE RECOMMENDATIONS AS ITS ORDERS WITH THE FOLLOWING MODIFICATION. THE COURT DOES NOT ADOPT THE PROVISION FOR DRUG TESTING AS SET FORTH ON PAGE TEN BEGINNING AT LINE FOUR. RATHER THE COURT IS MAINTAINING THE PRIOR ORDERS FOR DRUG TESTING AS SET FORTH IN THE PARTIES' STIPULATION OF JANUARY 30, 2023. THE COURT IS ADDING THE FOLLOWING PROVISION, IF RESPONDENT HAS COMPLIED WITH THE EMAIL NOTICE PROVISION TO PETITIONER'S COUNSEL WHICH INCLUDES THE REASON FOR THE REQUESTED TEST, AND PETITIONER FAILS TO TEST, THE TEST WILL BE CONSIDERED A POSITIVE TEST. THE COURT IS ADOPTING THE ABSTENTION ORDERS AS SET FORTH BEGINNING ON PAGE TEN LINE EIGHT. THE COURT IS ADOPTING THE REMAINING RECOMMENDATIONS WITHOUT FURTHER MODIFICATION. ALL PRIOR ORDERS NOT IN CONFLICT WITH THIS ORDER REMAIN IN FULL FORCE AND EFFECT. PETITIONER SHALL PREPARE AND FILE THE FINDINGS AND ORDERS AFTER HEARING.**

On December 22, 2022, the court adopted its tentative ruling, adopting the parties' agreements reached at Child Custody Recommending Counseling (CCRC). The CCRC report included a provision for a review hearing, however, the court inadvertently failed to include a review hearing as a part of its tentative ruling. On February 16, 2023, via an ex parte minute order set the review hearing for April 27, 2023.

Petitioner filed a Supplemental Declaration on April 12, 2023. Respondent was served by mail and electronically on April 11, 2023. Petitioner states in her Supplemental Declaration that although she may have some concerns, the current orders for custody and parenting time remain in the minors' best interest. Petitioner requests the current orders be maintained without modification.

Respondent has not filed a Supplemental Declaration.

The court has read and considered the filings as set forth above. The court finds the current orders remain in the best interest of the minors. All prior orders remain in full force and effect.

Petitioner shall prepare the Findings and Orders After Hearing.

Petitioner filed a Request for Order (RFO) on February 10, 2023, requesting the court order guideline child and temporary spousal support as well as order Family Code section 2030 attorney fees. Petitioner concurrently filed an Income and Expense Declaration. Respondent was served by mail on February 14, 2023.

Respondent filed a Responsive Declaration on April 17, 2023 as well as a Declaration of Counsel. Petitioner was served electronically on April 17, 2023. The court finds these filings to be late and therefore, has not considered them.

Parties are ordered to appear for the hearing.

**4. JENNIFER COWLES V. BENJAMIN COWLES**

On calendar for the present hearing date are two Requests for Order (RFO), both of which were filed by Respondent.

Motion to Compel

Respondent filed and served his Motion to Compel on February 6, 2023. Petitioner has not opposed the motion.

Respondent is requesting an order compelling Petitioner to provide full and complete responses to Requests to Produce numbers 1-24 as well as fees and costs in the amount of \$1,590. Of that amount, \$1,500 is to constitute sanctions while the remaining \$90 is to cover the filing fee. Respondent states the subject discovery requests were served on December 10, 2022. He has made several attempts to meet and confer and still has not received responses.

Generally speaking, "...a party may obtain discovery regarding any matter, not privileged, that is relevant to the subject matter involved in the pending action or to the determination of any motion made in that action, if the matter is itself admissible in evidence or appears reasonably calculated to lead to the discovery of admissible evidence." Cal. Civ. Pro. § 2017.010. There are a multitude of discovery methods available to the party seeking information, one of which is the ability to serve requests for production of documents and other tangible things pursuant to Civil Procedure section 2031.300. "A party to whom a demand for inspection, copying, testing, or sampling has been directed *shall respond separately to each item or category of item* by any of the following:" (1) a statement that the party will comply, (2) a statement that the party lacks the ability to comply, or (3) an objection to the demand or request made. Cal. Civ. Pro. §2031.210 (emphasis added). Where a party fails to provide timely responses the party to whom the discovery was directed waives "any objection...including one based on privilege or on the protection of work product..." Cal Civ. Pro. §2031.300(a).

Here, Respondent has provided the court with a copy of his December 10, 2022 requests for production, the requests do not have a Proof of Service attached evidencing their proper service on Petitioner. While Respondent states in his declaration that he served the requests on December 10<sup>th</sup>, this would not constitute proper service in accordance with Civil Procedure section 1013a which states, in pertinent part, the individual serving the documents must affirm that "he or she is over the age of 18 years and *not a party to the cause...*" Cal. Civ. Pro. § 1013a(1). Without establishing proper service, the court cannot grant Respondent's motion to compel or the sanctions associated with it.

Respondent's Motion to Compel is denied.

Modification of Child Support

Respondent seeks modification of current support orders on the basis that the timeshare for the children has changed. Support is currently calculated on the basis that Petitioner has all of the children 100% of the time. However, As of December 18<sup>th</sup>, Respondent received 100% custody of the two youngest children pending the return of a 3111 report. As such, Respondent requests modification of the support orders to be retroactive back to December 18, 2022. Both parties have filed current Income and Expense Declarations, however, there is no Proof of Service indicating that Respondent was served with Petitioner's declaration. The parties are ordered to appear.

Motion to be Relieved

Counsel for Respondent has filed a Motion to be Relieved as Counsel. The motion, as well as all supporting documents, were filed on February 8<sup>th</sup>. Counsel bases his motion on facts which he states are confidential pursuant to Business and Professions Code § 6068(e) and California Rules of Professional Conduct, rule 1.16. The parties are ordered to appear for in-camera hearing.

Request for Order

Respondent filed a Request for Order (RFO) on October 20, 2022 requesting guideline temporary spousal support and Family Code section 2030 attorney's fees in the amount of \$20,000. Respondent concurrently filed an Income and Expense Declaration, as well as a Declaration of counsel and a Declaration in support of his request. Petitioner was served on October 28, 2022.

Petitioner filed an Income and Expense Declaration on December 27, 2022. Respondent was served on December 22, 2022.

On January 10, 2023, by agreement of the parties, the court continued the hearing on the request for spousal support and attorney's fees, and set a review hearing for custody and parenting plan step-up for March 9, 2023 which was continued to the present date. Parties were ordered to file and serve Income and Expense Declarations as well as any supplemental declarations at least 10 days prior to the hearing date.

Petitioner filed her Income and Expense Declaration on March 7<sup>th</sup> which was served previously on February 23<sup>rd</sup>.

Respondent has not filed an updated Income and Expense Declaration as ordered. Given that he is the moving party, the court drops the matter from calendar.

Custody Review

The parties appeared before the court on January 10, 2023 for an evidentiary hearing on Petitioner's request for a Domestic Violence Restraining Order. At that time the court made custody orders and set the matter for a review hearing on March 9<sup>th</sup>, to join with Respondent's RFO. The March 9<sup>th</sup> hearing was continued to the present date.

Petitioner filed and served an Updating Declaration on March 3, 2023. Thereafter she filed and served a Supplemental Updating Declaration on March 8<sup>th</sup>. Respondent also filed a

supplemental declaration entitled Declaration of Nicholas Musgrove, Update on Supervised Visits. His declaration was filed and served on April 18<sup>th</sup>.

According to Petitioner, as of March 3<sup>rd</sup> Respondent had not scheduled any appointments for professional visitation with the children. She makes the following requests with regard to custody and visitation: Respondent to comply with the prior orders of the court to establish professional supervised visits within 5 days of the hearing date. Petitioner would like a return hearing scheduled. If Respondent does not provide the court with proof of completion of an intake process with a company to conduct the supervised visits, along with a showing of visits actually scheduled, Petitioner asks that the court vacate the current step-up plan and leave in place only the provisions for Respondent to have professionally supervised visits. She also asks that the court provide the parties with a signed copy of the DV-130.

In preparation for the present hearing, Respondent provided the court with supervised visit reports as of April 18<sup>th</sup>. Respondent has had supervised visits on March 17, 18, 21, 24, 30, 31, and April 6 and 8<sup>th</sup>. It appears the visits have been pleasant and without incident.

In light of the visit notes submitted the court finds it appropriate to move to unsupervised visits. Respondent may have one unsupervised visit with the children per weekend for a period of six hours during the day. Exchanges are to take place at a neutral location within El Dorado County. Respondent is admonished not to discuss the case, including the step-up plan or visitation orders, with the children. Failure to abide by court orders may result in the court amending the visitation schedule.

A review hearing is set for 6/29/2023 at 1:30 pm The parties are to file supplemental declarations updating the court on the status of the visits. Declarations are to be filed no later than ten days prior to the hearing date.

**TENTATIVE RULING #5: RESPONDENT'S REQUEST FOR ORDER IS DROPPED FROM CALENDAR. THE PARTIES ARE ORDERED TO APPEAR FOR AN IN-CAMERA HEARING ON THE MOTION TO BE RELIEVED AS COUNSEL. REGARDING CUSTODY, RESPONDENT MAY HAVE ONE UNSUPERVISED VISIT WITH THE CHILDREN PER WEEKEND FOR A PERIOD OF SIX HOURS DURING THE DAY. EXCHANGES ARE TO TAKE PLACE AT A NEUTRAL LOCATION WITHIN EL DORADO COUNTY. RESPONDENT IS ADMONISHED NOT TO DISCUSS THE CASE, INCLUDING THE STEP-UP PLAN OR VISITATION ORDERS WITH THE CHILDREN. FAILURE TO ABIDE BY COURT ORDERS MAY RESULT IN THE COURT AMENDING THE VISITATION SCHEDULE. A REVIEW HEARING IS SET FOR 6/29/2023 at 1:30pm THE PARTIES ARE TO FILE SUPPLEMENTAL DECLARATIONS UPDATING THE COURT ON THE STATUS OF THE VISITS. DECLARATIONS ARE TO BE FILED NO LATER THAN TEN DAYS PRIOR TO THE HEARING DATE.**

**6. MICHELLE GREENE V. JOSHUA SEATS**

On February 8, 2023, Respondent filed a Request for Order (RFO) seeking an order awarding him attorney's fees. Petitioner filed and served her Responsive Declaration to Request for Order and her Income and Expense Declaration on April 14<sup>th</sup>.

Respondent requests attorney's fees in the amount of \$5,000. He makes this request on the basis that Petitioner makes substantially more than he does, and he argues he was forced to retain an attorney after Petitioner misrepresented her income, day care expenses, and parenting time for the purpose of calculating child support. He also believes she has misrepresented the amount of income she receives from her rental properties. He states that Petitioner has not paid the prior award of attorney's fees, nor has she paid child support.

Petitioner opposes the order on the basis that she works two jobs, has the children the majority of the time and has little in the way of disposable income. She notes that the child support commissioner imputed income to Respondent and with the imputed income there is little disparity in income between the two. Additionally, she believes Respondent has brought this RFO simply in an effort to cause her psychological and financial distress and she does not have the resources to afford an attorney of her own. She believes that Respondent can pay for his attorney's fees from obtaining loans. Finally, she notes that she has paid the prior order for attorney's fees as well as all ordered child support.

The public policy of Family Code Section 2030 is to provide "at the outset of litigation, consistent with the financial circumstances of the parties, parity between spouses in their ability to obtain effective legal representation." IRMO Keech (1999) 75 Cal. App. 4th 860, 866; Kevin Q. vs. Lauren W. (2011) 195 Cal. App. 4th 633. This assures each party has access to legal representation to preserve each party's rights. It "is not the redistribution of money from the greater income party to the lesser income party," but rather "parity". Alan S. v Superior Court (2009) 172 Cal. App. 4th 238,251. The award must be just and reasonable; in taking into consideration what is just and reasonable, the court can take into consideration the need for the award to enable each party, to the extent practical, to have sufficient financial resources to present the party's case adequately. In addition to the parties' financial resources, the court may consider the parties' trial tactics. IRMO Falcone & Fyke (2012) 203 Cal. App. 4th 964; 975. The court must consider the impact of the fee award on the payor taking into account any orders for support. IRMO Keech, supra, at 860.

In awarding Family Code section 2030 attorney's fees, the court must determine whether a disparity exists in ability to pay for, and access to funds to retain counsel. This element has not been met. In so determining, the court has considered the parties' access to funds, ability to pay, income, and needs. The court grants Respondent's request for attorney's

fees under Family Code section 2030. In considering such an award the court is to ensure access to legal representation to preserve each party's rights. Here, the court finds there to be a significant disparity in income between the parties. Even with the imputation of minimum wage, Petitioner makes significantly more money both from her employment as well as her rental properties.

Because Petitioner is responsible for her living expenses as well as those of the children, the court has considered the method and timing of payment to ensure the payment does not constitute a financial burden on Petitioner. As such, Petitioner is ordered to pay Respondent's counsel \$5,000 as and for attorney's fees. The fee payments are to be made in monthly increments of \$500 until paid in full (approximately 10 months). Fee payments are due the first of the month beginning on May 1<sup>st</sup>.

**TENTATIVE RULING #6: THE COURT GRANTS RESPONDENT'S REQUEST FOR ATTORNEY'S FEES UNDER FAMILY CODE SECTION 2030. PETITIONER IS ORDERED TO PAY RESPONDENT'S COUNSEL \$5,000 AS AND FOR ATTORNEY'S FEES. FEE PAYMENTS ARE TO BE MADE IN MONTHLY INCREMENTS OF \$500 UNTIL PAID IN FULL (APPROXIMATELY 10 MONTHS). FEE PAYMENTS ARE DUE THE FIRST OF THE MONTH BEGINNING ON MAY 1<sup>ST</sup>. RESPONDENT IS TO PREPARE AND FILE THE FINDINGS AND ORDERS AFTER HEARING.**

**7. MOISA TELLEZ V. ALFREDO TELLEZ**

Petitioner requests orders modifying child support. Her Request for Order (RFO) was filed on February 9, 2023. It was electronically served the same day. The court notes this is a post-judgment motion for modification of support. In accordance with Family Code § 215 Petitioner has filed an address verification indicating that electronic service on counsel was agreed upon between the parties. On April 3<sup>rd</sup> Respondent filed a Declaration affirming that the information in his January 6<sup>th</sup> Income and Expense Declaration is still current and providing the court with his recent paystubs.

Petitioner makes her request on the basis that the parenting schedule, and therefore the timeshare, has changed pursuant to the Findings and Orders After Hearing for the September 8<sup>th</sup> hearing. She asks that the support orders be updated to accurately reflect the current timeshare.

Utilizing the figures as outlined in each party's respective Income and Expense Declaration and a 26% timeshare, the court finds that child support is \$280 per month. (See attached DissoMaster report.) The court adopts the attached DissoMaster report and orders Petitioner to pay Respondent \$280 per month as and for child support, payable on the 15th of the month until further order of the court or legal termination. This child support order is to be effective as of February 15, 2023.

The court finds both parties regularly earn overtime and commission income. To account for this the court has included a two-way overtime table to be used by the parties to calculate monthly true-up payments.

The court finds the above order results in arrears in the amount of \$840 through and including April 15, 2023. The court orders Petitioner to pay Respondent \$420 on the 15th of each month until paid in full (approximately 2 months).

**TENTATIVE RULING #7: THE COURT FINDS THAT CHILD SUPPORT IS \$280 PER MONTH. SEE ATTACHED DISSOMASTER REPORT. THE COURT ADOPTS THE ATTACHED DISSOMASTER REPORT AND ORDERS PETITIONER TO PAY RESPONDENT \$280 PER MONTH AS AND FOR CHILD SUPPORT, PAYABLE ON THE 15TH OF THE MONTH UNTIL FURTHER ORDER OF THE COURT OR LEGAL TERMINATION. Respondent filed a Request for Order (RFO) on February 8, 2023, requesting the court make child and spousal support orders as well as Family Code section 2030 attorney's fees. Respondent concurrently filed an Income and Expense Declaration. Petitioner was served by mail on February 8, 2023. Respondent requests the court order guideline child and temporary spousal support retroactive to the initial filing on May 7, 2023 under case number PFL20210223. Respondent asserts the voluntary support being paid by Petitioner is insufficient to support Respondent and the minors. Respondent requests Family Code section 2030 attorney's fees due to the disparity in income.

Petitioner filed a Responsive Declaration and Income and Expense Declaration on April 11, 2023. Respondent was served electronically on April 10, 2023. Petitioner objects to the award of support being made retroactive to the filing of the petition in case number PFL20210223. Petitioner asserts that issue was decided by this court on January 27, 2022 and is res judicata. Petitioner also objects to the court awarding Family Code section 2030 attorney's fees as Petitioner argues Respondent has chosen to be under employed, and therefore, the disparity in incomes is artificial. Petitioner appears to consent to guideline child and temporary spousal support. Petitioner requests the court issue Respondent a seek work order.

Utilizing each party's Income and Expense Declaration filed as set forth above, the court finds guideline child support to be \$1,363 per month (see attached DissoMaster report). The court orders Petitioner to pay Respondent \$1,363 per month as and for guideline child support effective March 1, 2023 and due on the 1<sup>st</sup> of each month until further order of the court or termination by operation of law. The court declines Respondent's request to make the order retroactive to the filing of the petition in case number PFL20210223 as the court finds that issue to be res judicata. The court denied child support on January 27, 2022.

The court finds this order results in an arrears balance of \$2,726, for the months of March and April. The court orders Petitioner pay Respondent \$340.75 per month as and for arrears effective May 15, 2023 and due on the 15<sup>th</sup> of each month until paid in full (approximately eight months). Any missed payment will result in the full balance being due with legal interest.

The court also finds Petitioner regularly earns overtime and has included an overtime table (see attached DissoMaster Overtime schedule). Petitioner is ordered to true up his earned overtime on a monthly basis.

Utilizing the same figures as set forth above, the court finds temporary guideline spousal support to be \$233 per month (see attached DissoMaster). The court orders Petitioner to pay Respondent \$233 per month as and for temporary guideline spousal support effect March 1,

2023 and due on the 1<sup>st</sup> of each month until further order of the court or termination by operation of law.

The court finds this order results in an arrears of \$466 for March and April. The arrears are offset by the voluntary support paid by Petitioner of \$700 per month and therefore, the court finds there are no arrears owing.

The public policy of Family Code Section 2030 is to provide “at the outset of litigation, consistent with the financial circumstances of the parties, parity between spouses in their ability to obtain effective legal representation.” IRMO Keech (1999) 75 Cal. App. 4th 860, 866; Kevin Q. vs. Lauren W. (2011) 195 Cal. App. 4th 633. This assures each party has access to legal representation to preserve each party’s rights. It “is not the redistribution of money from the greater income party to the lesser income party,” but rather “parity”. Alan S. v Superior Court (2009) 172 Cal. App. 4th 238,251. The award must be just and reasonable; in taking into consideration what is just and reasonable, the court can take into consideration the need for the award to enable each party, to the extent practical, to have sufficient financial resources to present the party’s case adequately. In addition to the parties’ financial resources, the court may consider the parties’ trial tactics. IRMO Falcone & Fyke (2012) 203 Cal. App. 4th 964; 975. The court must consider the impact of the fee award on the payor taking into account any orders for support. IRMO Keech, supra, at 860.

In awarding Family Code section 2030 attorney’s fees, the court must determine whether a disparity exists in ability to pay for, and access to funds to retain counsel. This element has not been met. In so determining, the court has considered the parties’ access to funds, ability to pay, income, and needs. The court finds that after the payment of support, Petitioner’s ability to pay for both his and Respondent’s attorneys’ fees has been significantly encumbered. Therefore, the court finds, Petitioner is not able to pay for both parties’ legal representation. As such, Respondent’s request for Family Code section 2030 attorney’s fees is denied.

Respondent has requested the court order Petitioner to seek work. The court notes Respondent is currently employed, however, not full time nor in a field in which she holds credentials. The court denies Petitioner’s request to issue Respondent a seek work order. However, the court notes it is the public policy of the state of California for parties to be self-supporting within a reasonable amount of time.

All prior orders not in conflict with this order remain in full force and effect. Respondent shall prepare and file the Findings and Orders After Hearing.
