On November 6, 2023, Petitioner filed a Request for Order (RFO) seeking orders for child support and attorney's fees. She filed her Income and Expense Declaration concurrently therewith. Both documents, along with all other required documents, were served on November 7th. Given that this is a post-judgment request for modification, Petitioner properly filed her Declaration Regarding Address Verification form. Petitioner filed and served an updated Income and Expense Declaration on January 24, 2024.

Respondent filed his Income and Expense Declaration on February 1st. There is no Proof of Service to establish that Petitioner was served with this document.

Petitioner's Reply Declaration to Respondent's Income and Expense Declaration was filed and served on February 1, 2024. Given that Petitioner did not object to Respondent's Income and Expense Declaration in her Reply, the court finds that she effectively waived any defect in service.

Petitioner filed her RFO seeking guideline child support as well as attorney's fees and costs in the amount of \$5,000 pursuant to Family Code section 2030. Petitioner's request for support is a change from the current support orders in the parties' Judgment wherein they agreed to set child support at \$0 and the parties agreed to each pay half of uninsured healthcare expenses of the minors. The change in circumstances to justify the requested change is the fact that Respondent is now gainfully employed. He was not employed at the time of the parties' agreement. To date, Petitioner has incurred attorney's fees and costs in the amount of \$17,560. She still owes \$8,252.80.

Petitioner notes that Respondent failed to provide his average monthly income and failed to attach his December paystubs to his Income and Expense Declaration. Petitioner obtained copies of those paystubs and based on them she requests the court use \$10,000 a month as Respondent's monthly income which constitutes an average of his regular and bonus income.

The court has reviewed Respondent's paystubs and it does appear that the vast majority of his income is comprised of bonuses and commissions. For example, in 2023 Respondent received only \$29,060.25 in regular wages (this includes sick time and PTO) but he received \$89,320.34 in overtime and bonuses. The court will utilize a bonus and overtime table.

Likewise, the court does not find \$3,665.21 to be an accurate reflection of Petitioner's monthly income either. Petitioner's monthly expenses are almost double her stated monthly income but she still has sufficient funds to save \$45,000 in her cash, checking, and other deposit accounts. Her Profit and Loss Statement shows a gross profit of \$146,359.76. This amount is

being used to pay personal expenses such as her mortgage, telephone, utilities, and legal fees. Therefore, \$12,196 (\$146,359.76 divided by 12) is a more accurate amount to be used for Petitioner's average monthly income.

Utilizing the figures as outlined above, the court finds that base guideline child support is \$708 per month payable from Respondent to Petitioner. The court adopts the attached DissoMaster report and orders Respondent to pay Petitioner \$708 per month as and for child support, payable on the 15th of the month until further order of the court or legal termination. This child support order is effective as of November 15, 2023.

The court finds the above order results in arrears in the amount of \$2,124 through and including January 15, 2024. The court orders Respondent pay Petitioner \$354 on the 1st of each month commencing on March 1, 2024 and continuing until paid in full (approximately 6 months). If any payment is late or missed the remaining balance is due in full with legal interest within five (5) days.

The court further finds both parties routinely earn income above the amounts utilized herein and therefore, has included an annual bonus table with the DissoMaster. The parties are to exchange Petitioner's Profit and Loss Statement and Respondent's W-2 no later than the 1st of each month. Utilizing those statements in conjunction with the DissoMaster bonus table, the parties are to calculate and adhere to the stated true-up amount. Parties are to true up the bonus and overtime income for November 15, 2023 through January 15, 2024, on or before March 1, 2024.

Regarding Petitioner's request for attorney's fees and costs, the request is denied. The public policy of Family Code section 2030 is to provide "at the outset of litigation, consistent with the financial circumstances of the parties, parity between spouses in their ability to obtain effective legal representation." In Re Marriage of Keech, 75 Cal. App. 4th 860, 866 (1999). This assures each party has access to legal representation to preserve each party's rights. In the face of a request for attorney's fees and costs, the court is to make findings on "whether there is a disparity in access to funds to retain counsel, and whether one party is able to pay for legal representation of both parties." Fam. Code § 2030(a)(2). Here, the court does not find a disparity in income sufficient to warrant fees at this time. Petitioner has a substantial amount available to her in her checking, savings, and deposit accounts which may be utilized to pay for her attorney's fees and costs. For these reasons, the request is denied.

Petitioner shall prepare and file the Findings and Orders After Hearing.

TENTATIVE RULING #4: THE COURT FINDS THAT CHILD SUPPORT IS \$1,898 PER MONTH. THE COURT ADOPTS THE ATTACHED DISSOMASTER REPORT AND ORDERS RESPONDENT TO PAY PETITIONER \$708 PER MONTH AS AND FOR CHILD SUPPORT, PAYABLE ON THE 15TH OF THE

MONTH UNTIL FURTHER ORDER OF THE COURT OR LEGAL TERMINATION. THIS CHILD SUPPORT ORDER IS EFFECTIVE AS OF NOVEMBER 15, 2023.

THE COURT FINDS THE ABOVE ORDER RESULTS IN ARREARS IN THE AMOUNT OF \$2,124 THROUGH AND INCLUDING JANUARY 15, 2024. THE COURT ORDERS RESPONDENT PAY PETITIONER \$354 ON THE 1ST OF EACH MONTH COMMENCING ON MARCH 1, 2024 AND CONTINUING UNTIL PAID IN FULL (APPROXIMATELY 6 MONTHS). IF ANY PAYMENT IS LATE OR MISSED THE REMAINING BALANCE IS DUE IN FULL WITH LEGAL INTEREST WITHIN FIVE (5) DAYS.

THE COURT FURTHER FINDS BOTH PARTIES ROUTINELY EARN INCOME ABOVE THE AMOUNTS UTILIZED HEREIN AND THEREFORE, HAS INCLUDED AN ANNUAL BONUS TABLE WITH THE DISSOMASTER. THE PARTIES ARE TO EXCHANGE PETITIONER'S PROFIT AND LOSS STATEMENT AND RESPONDENT'S W-2 NO LATER THAN FEBRUARY 15TH OF EACH YEAR. UTILIZING THOSE STATEMENTS IN CONJUNCTION WITH THE DISSOMASTER BONUS TABLE, THE PARTIES ARE TO CALCULATE AND ADHERE TO THE STATED TRUE-UP AMOUNT.

PETITIONER'S REQUEST FOR ATTORNEY'S FEES AND COSTS IS DENIED FOR THE REASONS SET FORTH ABOVE.

PETITIONER SHALL PREPARE AND FILE THE FINDINGS AND ORDERS AFTER HEARING.

On October 10, 2023, this matter came before the court for a short cause trial on the issues of child custody and visitation. Petitioner failed to appear despite having been properly noticed of the hearing. Therefore, the court found good cause to move forward with the hearing. At the completion of the hearing the court found the statutory presumption established by Family Code section 3044 applied and therefore awarded Respondent sole legal and sole physical custody of the minor. The court made orders regarding supervised visits for Petitioner and ordered Petitioner to participate in individual therapy. A review hearing was set for the present date to review Petitioner's participation in the supervised visits, and individual therapy, and to assess the status of the 3044 presumption.

Minor Counsel's Statement of Issues and Request for Orders was filed on January 16, 2024. It was electronically served on January 11th. Respondent filed and served his Declaration on January 30th. Petitioner has not filed a declaration.

According to Respondent, Petitioner has not exercised any visitation with the child since the October 10th ruling and he has not been informed that Petitioner has completed individual counseling as ordered. Respondent requests the current orders remain in place. He further requests that the minor be allowed to travel with him outside of Sacramento County and outside the state of California to visit maternal and paternal family.

Minor's Counsel also requests that the orders for sole legal and sole physical custody remain in place. She agrees that Respondent should be allowed to travel out of the county and out of state with the minor to visit family. While Minor's Counsel notes that the minor has expressed that he misses Petitioner, Petitioner has made no attempt to contact or visit the minor in approximately one year thus raising concerns over the impact on the minor were Petitioner to suddenly decide to exercise her visitation rights. Minor's Counsel asks that Petitioner's visits with the minor be temporarily suspended. Should Petitioner decide she would like visits with the minor in the future she can file a Request for Order.

The court has reviewed the filings of the parties as outlined above and finds that Respondent's sole legal and sole physical custody remains in the minor's best interests. Given that Respondent has sole legal and sole physical custody of the minor, he may travel out of the county and out of state with the minor without Petitioner's prior notice or consent. Additionally, Minor's Counsel's request to suspend Petitioner's visitation for the time being is granted. Given that there has been an exceptionally long period of time since Petitioner has made any effort to see or even contact the minor, the court is concerned about the ramifications on the minor should Petitioner suddenly reappear in his life. If circumstances are to change in the future, Petitioner may file a Request for Order to re- establish visitation.

This matter came before the court on August 3, 2023 for hearing on a Request for Order (RFO) filed by Petitioner requesting custody, visitation, support, and property control orders as well as attorney's fees. The court ruled on all matters and set a review hearing on November 2, 2023 to address the issue of child support and determine whether or not it would be in the best interest of the children to liberalize Respondent's visitation.

On November 2nd the court found that the § 3044 presumption had been rebutted and the court modified Respondent's visitation to be fully unsupervised from 9:00 am to 6:00 pm every 1st, 2nd, 3rd, and 5th weekend of the month. The court also made orders regarding a holiday schedule, the children's birthday, and exchanges. The parties were referred to Child Custody Recommending Counseling (CCRC) and a review hearing was set for the present date.

Respondent filed his Income and Expense Declaration on January 18, 2024. It was mail served on January 12th. Petitioner filed her Income and Expense Declaration and an MC-030 Declaration on January 23, 2024. They were mail served on January 26th.

According to Petitioner, Respondent has exercised his visits, though he is refusing to give any allergy medication to the parties' son nor is he giving the children medication when they are sick. Additionally, Respondent has refused to complete any ABA daily data collection as required by the therapist for the parties' daughter. Petitioner requests the following orders: (1) Respondent's parenting time to be every other Saturday from 8am-5pm; (2) Respondent to be in the immediate presence of the children throughout the entirety of his parenting time; (3) Petitioner to have the right of first refusal if Respondent is not able to be in the immediate presence of the children throughout his parenting time; (4) Pick up and drop off of the minor children to continue at a staffed law enforcement facility; (5) sole legal and sole physical custody to remain with Petitioner; (6) Increase Respondent's requirement to pay Petitioner's attorney's fees from \$2,500 to \$7,500; (7) Extend Petitioner's deadline to retain an attorney from October 15, 2023 to May 1, 2024; and (8) the court to recalculate all child support/spousal support/arrears based on Respondent's actual income.

The parties attended CCRC on December 18, 2023 but were unable to reach any agreements. On January 25, 2024, a report with recommendations was prepared by the CCRC counselor. The court has reviewed the recommendations and finds them to be in the best interests of the children. Therefore, the recommendations as stated in the January 25, 2024 CCRC report are hereby adopted as the orders of the court. Additionally, the court orders the pick-up and drop off of the minors to occur at a staffed law enforcement facility and Petitioner should have the right of first refusal to care for the children in the event Respondent is unable

to care for them for a consecutive period of 8 hours or more. All prior orders not in conflict with this order remain in full force and effect.

Petitioner's request for increased attorney's fees is denied as it is outside the scope of this review hearing. The court ruled on this issue at the August 3rd hearing on Petitioner's RFO. If Petitioner seeks additional attorney's fees then she must do so by filing a new RFO.

Regarding support, the parties are ordered to appear to discuss Petitioner's assertions that Respondent's monthly income is higher than the amount reported on his Income and Expense Declaration.

Petitioner shall prepare and file the Findings and Orders After Hearing.

On November 3, 2023, Petitioner filed and served a Request for Order (RFO). Respondent filed and served his Responsive Declaration to Request for Order on January 30, 2024. As of the time of this writing, Petitioner has not filed a Reply.

Petitioner brings her RFO requesting the following orders: (1) Allow the children to attend counseling, either a private counselor or a counselor through their school, without Respondent's permission; (2) Sell the former family residence located on Pigeon Trail in River Pines; (3) Appoint the clerk as elisor to sign any and all necessary sale documents if Respondent is unwilling to cooperate; and (4) Respondent's share of proceeds from the sale of the former family residence to be utilized to pay child and spousal support arrears (totaling \$47,401) as well as the amount due on payments toward the buy-out of Petitioner's interest in the former family residence (\$3,900). Petitioner requests the balance of the proceeds to be placed in an interest-bearing account pending the division of the remainder of the marital property.

Regarding the sale of the Pigeon Trail residence, Petitioner requests an order directing Respondent to propose the names of 3 realtors within 10 days of the court's order and Petitioner will choose one of the 3 names within two days of receipt thereof. In the event Respondent fails to propose realtors within the allotted time period, Petitioner requests authority to choose a realtor on her own and the realtor to set the listing price of the residence. Petitioner requests authority to sign the listing agreement, without Respondent's signature, in the event Respondent refuses to sign the listing agreement within five days of his receipt thereof.

Respondent agrees to allow the children to attend counseling. He also agrees to the sale of the community property residence, though he does not agree to the appointment of the clerk as elisor. Further, he does not agree with the proposed arrears calculation and requests the court reserve jurisdiction on this issue until the hearing on his RFO.

According to Respondent, he has already signed a release allowing the children to attend counseling services with the school counselor. For that reason, in addition to the fact that the parties share joint legal custody of the children, Petitioner's request to enroll the children in counseling without Respondent's permission is denied.

Likewise, Respondent states that he has already agreed to sell the former family residence and he has already provided the names of three real estate agents. Therefore, the court finds Petitioner's request for an order directing the parties to sell the former family residence to be moot and as such, the court declines to rule on this request. Petitioner's request to have the clerk appointed as elisor is denied for the time being. Petitioner makes this request in anticipation that Respondent will not actively participate in the sale of the home,

however, he has shown otherwise given that he has already begun the process of listing the home for sale. In the event that Respondent declines to cooperate in the future, Petitioner may file an RFO at that time.

Finally, the parties agree that Petitioner shall be paid the remaining portion of the amount stipulated for her interest in the former family residence. Therefore, upon the sale of the home, Petitioner shall be paid \$3,900 as and for the buyout of her interest from the residence as stipulated by the parties. The remainder of the proceeds shall be placed in an interest-bearing account pending the court's determination on arrears and property division.

As noted by Respondent, there is an RFO for child and spousal support pending which is set to be heard on April 18th. In the interest of judicial economy, the court continues Petitioner's request to utilize Respondent's share of the proceeds to pay child and spousal support arrears owed by Respondent. The court reserves jurisdiction on child and spousal support back to the date of filing the November 3rd RFO.

Petitioner shall prepare and file the Findings and Orders After Hearing.

TENTATIVE RULING #9: PETITIONER'S REQUEST TO ENROLL THE CHILDREN IN COUNSELING WITHOUT RESPONDENT'S PERMISSION IS DENIED. THE COURT FINDS PETITIONER'S REQUEST FOR AN ORDER DIRECTING THE PARTIES TO SELL THE FORMER FAMILY RESIDENCE TO BE MOOT AND AS SUCH, THE COURT DECLINES TO RULE ON THIS REQUEST. Respondent filed a Request for Order (RFO) on July 11, 2023, requesting modifications to the current orders for child custody and parenting time. The parties were referred to Child Custody Recommending Counseling (CCRC) for an appointment on September 14, 2023 and a review hearing on November 2, 2023. The court notes this is a post-judgment request for modification. Petitioner was personally served on July 18, 2023, in accordance with Family Code section 215.

Respondent is requesting joint legal and physical custody with a week-on/week-off parenting plan.

Only Petitioner appeared for the CCRC appointment on September 14, 2023. As such a single parent report was filed with the court on October 18, 2023. The court notes Respondent attempted to participate in the CCRC appointment telephonically due to illness, however, did not timely make the request to do so.

On November 2, 2024 the court rereferred the parties to CCRC for a further appointment on December 20, 2023 and a further review hearing on February 8, 2024.

Both parties attended CCRC on December 20, 2023 and reached a full agreement. A report memorializing the parties' agreement was filed with the court on January 25, 2024. Copies were mailed to the parties on January 26, 2024.

Petitioner filed a Responsive Declaration on January 26, 2024. There is no Proof of Service for this Document, therefore, the court cannot consider it.

The court has read and considered the filings as set forth above. The court finds the agreement of the parties to be in the minors' best interests. The court adopts the parties' agreement as its order.
