ANNUAL STATUS REVIEW

Letters of Guardianship of the person were issued on March 2, 2022. The annual guardianship status report (Judicial Council form GC-251) was not filed by the guardian for the May 13, 2026 hearing. The court continued the matter to July 1, 2026 and directed the clerk to provide notice to the guardian.
