

**1. Guardianship of Allie V. PP20170115
ANNUAL STATUS REVIEW**

Letters of Guardianship of the person were issued in August 30, 2017. The annual guardianship status report (Judicial Council form GC-251) was filed by the one of the guardians on May 20, 2026. Upon review of the court, the court finds that the guardians are going through a separation/divorce. The court ordered the guardians to appear at the June 10, 2026 hearing to assess whether it makes sense to still have both guardians serve as the guardians for the minor. Neither guardian appeared. The court continued the matter to July 8, 2026.

A Petition to Appoint a Guardian and Temporary Petition was filed on April 16, 2026. The court granted the temporary guardianship on April 29, 2026. Both parents, the paternal grandfather, and the maternal grandmother signed consents for appointment of the paternal grandmother as the guardian. The maternal grandfather is deceased. The court has yet to receive the investigative report. The court reissues the temporary guardianship and continues the matter to allow additional time for the investigative report to be completed.
