

**1. GUARDIANSHIP OF GRACIE C. PP20180055**

**Annual Status Review Hearing**

Letters of Guardianship of the person were issue on August 7, 2018. The annual guardianship status report (Judicial Council Form GC-251) was filed by the guardian on 7/3/23. Having read and considered the report, the court finds the guardianship remains necessary and shall continue.

A notice of hearing was filed on 7/13/23 with proof of service to both parents and the maternal grandfather, Darrell Pingree. A declaration of due diligence was filed as to the maternal grandmother, Tracey Daniel, on 6/20/23. Both paternal grandparents are deceased. The court finds that notice was given as required by law.

The probate investigator report was filed on 7/27/23 recommending that guardianship of the wards be established and that Shannon and Charity Nielson be appointed guardians of the person. The court does not have a response from the Department of Justice regarding the result of a criminal background check.
