APPOINT GUARDIAN**

A petition to appoint a temporary guardian and a petition to appoint a guardian for the minor were filed on 8/7/23. Both parents appeared at the hearing on the petition to appoint a temporary guardian on 8/14/23. The court denied the petition for temporary guardianship. A notice of hearing was filed on 8/9/23 with proof of service to Jon Timberlake, Karen Boek, Gregory Boek, and Jordyn Timberlake. A notice of hearing was filed on 8/14/23 with proof of service on Tyler Boek. No proof of service has been filed establishing notice to Delilah Elkerton (assuming she is over the age of 12).

The probate investigator report was filed on 9/20/23 recommending that the petition for guardianship be denied. The minor was observed in the mother's home by Sacramento County Child Protective Services and there were no safety concerns. The mother has submitted clean drug test to CPS in Sacramento County. Father also reports that he can safely care for the minor at this time. Mother filed a written objection to guardianship on 8/14/2023. The court finds that guardianship is NOT necessary for the protection of the minor at this time. The petition to appoint a guardian is denied.
