

**1. Guardianship of Dillen M. 26PR0035
READINESS CONFERENCE**

The court orders appearances to assess readiness for trial.

2. Guardianship of Cecelia A. 26PR0077
APPOINT GUARDIAN

A Petition to Appoint a Guardian and Temporary Petition was filed on March 23, 2026. Letters of Temporary guardianship were issued on April 1, 2026. The father signed a consent for appointment for the proposed guardians. At the April 29, 2026 hearing, the matter was continued to May 13, 2026 to give proposed guardians an opportunity to serve mother with notice. The mother and proposed guardians appeared at the May 13, 2026 hearing. Mother initially objected, but then consented to the temporary guardianship pending the next hearing and also consented to the minor traveling with the temporary guardians out of the country. At the June 17, 2026 hearing, the court continued the matter to July 29, 2026, and reissued the temporary guardianship as no report had been received. The court still has not received the investigator's report.

**3. Guardianship of Remi Lillian Caldwell 26PR0208
APPOINT GUARDIAN**

A petition to Appoint a Guardian and Temporary Petition was filed on July 17, 2026. At the July 29, 2026 hearing, the court dispensed with notice to the father and the maternal grandfather and granted the temporary guardianship. The paternal grandparents, maternal grandmother, and mother were served with notice of the hearing on the petition for appointment of a guardian set on September 2, 2026; however, service was effectuated on August 19, 2026, less than the 15 days prior to the hearing required by law. The mother filed an objection to the petition for guardianship on August 25, 2026. The Court investigator's report recommends guardianship be granted as it is in the best interests of the child.

**4. Guardianship of the Estate of Hunter M. 24PR0343
ACCOUNTING HEARING**

Letters of Guardianship of the Estate were issued on March 26, 2025. **At the August 12, 2026 hearing, the court noted that no formal accounting had been filed. The court directed the guardian to file a declaration with copies of statements for the guardianship account immediately following the last the accounting hearing on August 13, 2025 and the most recent statement. On August 31, 2026, the guardian filed a declaration with the transaction history of the account certified by the bank, showing only deposits into the account and no withdrawals. The court finds that this documentation is sufficient to satisfy the accounting requirement for this year. The court set another accounting in a year and orders the guardian to file an accounting at least two weeks in advance of the hearing confirming all activity in the account.**

TENTATIVE RULING #4: THE COURT SETS AN ACCOUNTING HEARING AT 1:30 P.M. ON AUGUST 4, 2027 IN DEPARTMENT 8. THE GUARDIAN SHALL FILE AN ACCOUNTING AT LEAST TWO WEEK IN ADVANCE OF THE HEARING THAT CONFIRMS ALL ACTIVITY IN THE ACCOUNT FROM AUGUST 2026 TO THE DATE OF FILING THE ACCOUNTING.

5. Guardianship of Braxton M. 25PR0257
APPOINT GUARDIAN

A Petition to Appoint a Guardian and Temporary Petition was filed on September 23, 2025. The temporary guardianship was granted on November 21, 2025 and reissued multiple times, most recently on July 8, 2026. The Court received and has reviewed the investigative report which recommends the approval of the petition. At the July 8, 2026, the mother waived any further service of the petition and was noticed of the next hearing date on September 2, 2026. Upon review of the file, there is no indication that the father has been served with the petition nor been given notice of the hearing.

**6. Guardianship of Debra and Rita A. PP20140164
ANNUAL REVIEW**

Letters of Guardianship of the person were issued on March 25, 2015. The annual guardianship status reports (Judicial Council for GC-251) were filed on by the guardian on March 16, 2026. Having read and considered the report for the April 15, 2026 hearing, the court had concerns about the minors' progress in school and ordered the parties to appear to inquire further. No parties appeared, so the court referred the matter to Quest for an investigation under Probate Code Section 1513.2, subdivision (a) and continued the matter to May 13, 2026. Quest filed its report on June 15, 2026, which the court has reviewed. The report recommends that an alternate placement be considered for the minors. At the July 29, 2026 hearing, the parties consented to the court reaching out to the local tribal court to see if the minors are members and might be eligible for services from the tribe. The court continued the matter to September 2, 2026.

**7. Guardianship of Jade Camryn T. 26PR0248
APPOINT TEMPORARY GUARDIAN**

A Petition to Appoint a Guardian and Temporary Petition was filed on August 17, 2026. The petitioner is the minor in this case and asking to have her maternal grandmother be appointed as her guardian. The maternal grandmother consents to the appointment.

**8. Guardianship of Manaia, Lena, and Saige P. PP20170053
ANNUAL REVIEW**

Letters of the Guardianship of the person were issued on November 8, 2017. The annual guardianship status report (Judicial Council for GC-251) was filed on August 26, 2026. The Guardian did not attach a report card to the status reports. Court appointed counsel filed a minor's counsel statement on August 28, 2026 asking for a termination of guardianship and to live with the father, though no termination of guardianship has yet been filed.
