

**1. Guardianship of Cecilia A. 26PR0077
PETITION TO APPOINT GUARDIAN**

A Petition to Appoint a Guardian and Temporary Petition was filed on March 23, 2026. Letters of Temporary Guardianship were issued on April 1, 2026. The father signed a signed a consent for appointment of the proposed guardians. At the April 29, 2026 hearing, the matter was continued to May 13, 2026 to give proposed guardians an opportunity to serve mother with notice. The mother and proposed guardians appeared at the May 13, 2026 hearing. Mother initially objected, but then consented to the temporary guardianship pending the next hearing and also consented to the minor traveling with the temporary guardians out of the country. At the June 17, 2026 hearing, the court continued the matter to July 29, 2026 and reissued the temporary guardianship as not report had been received yet. The court still has not received the investigator's report.

**2. Guardianship of Remi C. 26PR0208
PETITION TO APPOINT GUARDIAN**

A Petition to Appoint a Guardian and Temporary Petition was filed on July 17, 2026. The father is deceased, and notice of the hearing on the temporary guardianship was given to the mother, paternal grandparents, and maternal grandmother. Petitioners request that the court dispense with notice to the father and maternal grandfather. The court dispenses with notice to the father but has additional questions regarding efforts to locate the maternal grandfather. The court finds good cause to grant the temporary guardianship. Service will need to be provided to the mother and the grandparents for the hearing on the petition for appointment of a guardian set on September 2, 2026. Petitioners are ordered to appear regarding the request to dispense with notice as to the maternal grandfather.

TENTATIVE RULING #2: THE COURT APPOINTS THE PROPOSED GUARDIANS AS THE TEMPORARY GUARDIANS PENDING THE SEPTEMBER 2, 2026 HEARING. THE COURT ORDERS THE TEMPORARY GUARDIANS TO APPEAR REGARDING THE REQUEST TO DISPENSE WITH NOTICE TO THE MATERNAL GRANDFATHER.

**3. Guardianship of Brionna C. PP20210055
ANNUAL STATUS REVIEW**

Letters of Guardianship of the person were issued in January 25, 2022. The annual guardianship status report (Judicial Council form GC-251) was filed by the guardian on July 14, 2026. Having read and considered the report, the court finds and orders the guardianship remains necessary and shall continue.

TENTATIVE RULING #3: GUARDIANSHIP SHALL CONTINUE. THE COURT SETS THE NEXT ANNUAL STATUS REVIEW FOR AUGUST 4, 2027 AT 1:30 P.M. IN DEPARTMENT 8.

**4. Guardianship of Debra and Rita A. PP20140164
ANNUAL STATUS CASE REVIEW**

Letters of Guardianship of the person were issued on March 25, 2015. The annual guardianship status reports (Judicial Council for GC-251) were filed on by the guardian on March 16, 2026. Having read and considered the report for the April 15, 2026 hearing, the court had concerns about the minors' progress in school and orders the parties to appear to inquire further. No parties appeared, so the court referred the matter to Quest for an investigation under Probate Code section 1513.2, subdivision (a) and continued the matter to May 13, 2026. Quest requested a continuance of the matter to have more time to complete the report. The guardian appeared at the May 13, 2026 hearing, and the court continued the matter to June 17, 2026. Per the tentative ruling, there was no Quest report in the file for the June 17, 2026 hearing, so the court continued the matter to July 29, 2026. The court finds that there is still no Quest report in the file, so the court continues the matter to September 2, 2026 at 1:30 p.m. in Department 8.

TENTATIVE RULING #4: THE COURT CONTINUES THE HEARING TO SEPTEMBER 2, 2026 AT 1:30 P.M. IN DEPARTMENT 8.
