

1. CONSERVATORSHIP OF LOUIS B., 22PR0188**Annual Review Hearing**

This matter was continued from March 21, 2025, upon the request of the Public Guardian, as it needed additional time to complete its accounting and report.

Letters of conservatorship of the person and estate were issued on August 18, 2022. The court investigator's report indicates that the conservatee wishes to petition the court for termination of the conservatorship. Counsel for the conservatee also made this representation in court on March 21, 2025. However, the court investigator's report indicates that continuation of the conservatorship is recommended. To date, there is no petition to terminate the conservatorship in the court's file.

Absent objection, the Second Annual Account is allowed, settled, and approved as rendered. The court finds that government benefit monies are necessary to sustain the support and maintenance of the conservatee. Therefore, the court will authorize the requests for compensation.

TENTATIVE RULING # 1: THE SECOND ANNUAL ACCOUNTING IS ALLOWED, SETTLED, AND APPROVED AS RENDERED. COMPENSATION IS ALLOWED AS REQUESTED. THE COURT SETS THE NEXT ANNUAL REVIEW HEARING AT 8:30 A.M., FRIDAY, APRIL 17, 2026, IN DEPARTMENT FOUR.
