

1. CONSERVATORSHIP OF ROSEMARIE G., SP20130007

TWELFTH AND THIRTEENTH (FINAL) ACCOUNTINGS

The conservatee passed away on January 30, 2025. Therefore, the conservatorship has terminated by operation of law. (Prob. Code, § 1860.)

Before the court are the Twelfth and Thirteenth and Final Accountings. Absent objection, the accountings are allowed, settled, and approved as rendered.

At the status hearing on April 4, 2025, counsel for the administrator indicated he was having difficulty receiving financial documents from the IRS. The court granted counsel's request for a continuance.

4. ESTATE OF REINHOLD, 23PR0309**(A) Petition for Final Distribution****(B) Status of Administration**

Pending before the court is the petition for final distribution.

The decedent's heirs (decedent's mother and decedent's four siblings) each signed a waiver of account.

Paragraph 19 of the petition for final distribution alleges that 100 percent of the estate should be distributed to the administrator of the estate, Tiffany Reinhold (the decedent's ex-spouse). However, the decedent died intestate. Therefore, the decedent's estate must be distributed according to the state's intestate succession laws. (See Prob. Code, § 6400, et seq.) Survived by the decedent are his mother and four siblings. Under intestate succession law, the entire estate passes to the decedent's mother. (Prob. Code, § 6402, subd. (b).)

At the hearing on June 27, 2025, the administrator informed the court that she intended to obtain a waiver of distribution of assets from the decedent's mother.

On July 1, 2025, the administrator submitted a waiver of right to distribution executed by the decedent's mother's power of attorney (the administrator also submitted proof of the power of attorney). The waiver assigns all of the decedent's mother's rights to distribution to the administrator. Accordingly, and notwithstanding Probate Code section 6402, the entire estate shall be distributed to the administrator.
