1. GUARDIANSHIP OF CORA AND AILA C., 23PR0207

Petition to Appoint Guardian

On September 8, 2023, the court issued letters of temporary guardianship of the person for both minors.

On November 6, 2023, the court investigator informed the court that the minors' mother resumed her medications, is currently stable, and has returned to Arkansas with the subject minors. As such, the court investigator recommended that the proposed guardian file a request for dismissal. The court will drop this matter from the calendar.

TENTATIVE RULING # 1: MATTER IS DROPPED FROM THE CALENDAR.

2. GUARDIANSHIP OF ALEXIS R., 23PR0249

Petition to Appoint Guardian

The maternal grandfather of the proposed ward petitions to be appointed guardian of the person. On October 26, 2023, the court issued letters of temporary guardianship of the person.

"Upon hearing of the petition, if it appears necessary or convenient, the court may appoint a guardian of the person or estate of the proposed ward or both." (Prob. Code, § 1514, subd. (a).) The court applies a clear and convincing evidence standard of proof to its determination of whether or not it appears necessary or convenient to appoint a guardian, whether or not granting custody to a parent would be detrimental to the child, and whether or not granting custody to the nonparent is required to serve the best interests of the child. (*Guardianship of Jenna G.* (1998) 63 Cal.App.4th 387, 394.)

Petitioner filed the mandated (1) Child Information Attachment form for the Probate Guardianship petition (Form GC-210(CA)); (2) Duties of Guardian and Acknowledgment of Receipt form (Form GC-248); (3) Confidential Guardian Screening Form (GC-212); (4) Declaration Under UCCJEA (Form FL-105GC120); and (5) Consent of Proposed Guardian (Form GC-211).

Notice

The proposed ward's parents are not entitled to notice. (Prob. Code, § 1511, subd. (f)(2).) There is no proof of service in the court's file establishing that the proposed ward (age 16) was personally served notice of the hearing and a copy of the guardianship petition. (Prob. Code, § 1511, subd. (b).)

Reports

To date, a DOJ live scan report concerning petitioner is not in the court's file. The court investigator's report is also not in the court's file.
