6. GUARDIANSHIP OF WILLIAM B., 23PR0161**Visitation Hearing**

On November 8, 2023, the court issued an order granting Letters of Guardianship of the person and the estate to the maternal grandmother and her husband. Pending before the court is the issue of the paternal grandparents' visitation rights. Petitioners have informed the court that the parties have been unable to reach an agreement.

The paternal grandparents are requesting: (1) each calendar year, a two-week visit that does not conflict with the minor's school schedule; (2) a telephone call from the minor on every federal holiday, Mother's Day, and the minor's birthday (and any additional telephone calls the minor desires); (3) health updates, including updates regarding the minor's autism; and (4) photographs of the minor.

Petitioners object to an annual two-week visit, noting that the minor has never spent the night at his paternal grandmother's house and has not seen his paternal grandmother in two years. Instead, petitioners would like to facilitate 10 one-day visits with the paternal grandparents each calendar year. As for the telephone calls, petitioners request that the minor not be required to call the paternal grandparents on Mother's Day, as it is a particularly difficult day for the minor. Petitioners are agreeable to the paternal grandparents' request for health updates and photographs.
