### 1. CONSERVATORSHIP OF BRIAN S., PP20120113

### **Biannual Review Hearing**

Currently before the court is a Tenth and Eleventh accounting. The Public Guardian is requesting fees in the amount of \$5,302.00 and County Counsel is requesting fees in the amount of \$11,040.20. Counsel for the conservatee objects to the requested fees under Probate Code section 1851.5, arguing there is a presumption that the imposition of the fees will create a hardship, and petitioner should be required to overcome that burden.

Probate Code section 1851.5 provides, "Each court shall assess each conservatee in the county for *any investigation or review conducted by a court investigator with respect to that person*. Subject to Section 68631 of the Government Code, the court may order reimbursement to the court for the amount of the assessment, unless the court finds that all or any part of the assessment would impose a hardship on conservatee or the conservatee's estate. There shall be a rebuttable presumption that the assessment would impose a hardship if the conservatee is receiving Medi-Cal benefits." (Prob. Code, § 1851.5 [emphasis added].)

Here, counsel for the conservatee argues, "Because [the conservatee] receives governmental assistance, and that appears to be the overwhelming majority of his income, there is a presumption that the imposition of the requested fees would create a hardship." (Mtn. at 2:10–11.) The instant request for compensation, however, does not relate to an investigation or review conducted by a court investigator with respect to the conservatee. Rather, it is a request for periodic compensation to the conservator and the conservator's attorney. Therefore, Probate Code section 1851.5 does not apply.

The court may authorize periodic payments on account to the guardian or conservator or attorney, pursuant to Probate Code section 2640, et seq. There is a limitation, however, that the guardian, conservator, or attorney shall not be compensated with any government benefits program monies unless deemed by the court as necessary to sustain the support and maintenance of the ward or conservatee. (Prob. Code, § 2640, subd. (e).)

Having reviewed the Tenth and Eleventh Accounting, the court finds that virtually all of the conservatee's income was in the form of governmental assistance. The court finds that government benefit monies are necessary to sustain the support and maintenance of the conservatee. Therefore, the court will authorize the request for compensation.
