

1. CONSERVATORSHIP OF SUSAN W., SP20100037**Biennial Review (Fourteenth and Fifteenth Account and Report)**

Before the court is the biennial review of the conservatorship of the person and the estate. The court investigator's report recommends continuation of the conservatorship. Pursuant to Probate Code section 1851.5, the court finds that assessment of the court investigator fee would cause a hardship to the conservatorship and will not require reimbursement of the investigator's fee.

On December 19, 2025, petitioner submitted the Fourteenth and Fifteenth Account. Absent objection, the account is allowed, settled, and approved as rendered. The court authorizes the following fees to be paid by the conservatee's estate: (1) \$748.00 to the petitioner; and (2) \$287.00 to El Dorado County Counsel.

TENTATIVE RULING # 1: ABSENT OBJECTION, THE CONSERVATORSHIP SHALL CONTINUE. THE FOURTEENTH AND FIFTEENTH ACCOUNTINGS ARE ALLOWED, SETTLED, AND APPROVED AS RENDERED. THE COURT AUTHORIZES THE FOLLOWING COMPENSATION REQUESTS TO BE PAID BY THE CONSERVATEE'S ESTATE: (1) \$748.00 TO PETITIONER; AND (2) \$287.00 TO EL DORADO COUNTY COUNSEL. THE COURT FINDS THAT ASSESSMENT OF THE COURT INVESTIGATOR FEE WOULD CAUSE A HARDSHIP TO THE CONSERVATORSHIP AND WILL NOT REQUIRE REIMBURSEMENT OF THE FEE. THE COURT SETS THE NEXT BIENNIAL REVIEW HEARING AT 8:30 A.M., FRIDAY, JANUARY 21, 2028, IN DEPARTMENT FOUR.
