

1. CONSERVATORSHIP OF KASSANDRA S., 26PR0124

Petition to Appoint Limited Conservator

This matter was continued from June 12, 2026, because the assessment report from the Alta Regional Center had not been submitted. (Prob. Code, § 1827.5, subd. (a).) The court directed the regional center to prepare and submit a report and emailed a copy of the minute order to the regional center. To date, the report is still not in the court's file.

2. ESTATE OF CAPPS, 24PR0138**Status of Administration**

On November 22, 2024, the court granted the petition for final distribution. At the last hearing on April 24, 2026, counsel requested another three-month continuance to obtain the receipts of distribution. To date, there are still no receipts in the court's file.

3. ESTATE OF FEJER, 24PR0077**Status of Administration**

Letters of administration with Will Annexed were issued on May 31, 2024. On September 9, 2024, the executor filed a partial inventory and appraisal, which states “[t]he only assets within the estate will be funds from a potential settlement related to the Camp Lejeune mass tort claim. At the time of receipt of any potential settlement funds, the Petitioner will file a final Inventory and Appraisal.”

There were no appearances at the status hearing on June 26, 2026, even though appearances were required.

4. GUARDIANSHIP OF ELIAN O., 23PR0299**Annual Review Hearing**

Letters of guardianship of the person were issued on May 10, 2024. There were no appearances at the last two hearings (June 5 and 26, 2026) even though appearances were required. The court mailed and emailed a copy of its June 26, 2026, minute order to the guardian; however, the mailing was returned undeliverable. To date, the guardian has not submitted the annual guardianship status report (Judicial Council form GC-251).
