Petition to Approve First and Final Account and Final Distribution

TENTATIVE RULING # 1: ABSENT OBJECTION, PETITION GRANTED AS REQUESTED.

2. ESTATE OF FEJER, 24PR0077**Status of Administration**

This matter was continued from June 12, 2026, upon the request of the executor's attorney, who informed the court he was unable to sign up for remote appearance.

Letters of administration with Will Annexed were issued on May 31, 2024. On September 9, 2024, the executor filed a partial inventory and appraisal, which states, "The only assets within the estate will be funds from a potential settlement related to the Camp Lejeune mass tort claim. At the time of receipt of any potential settlement funds, the Petitioner will file a final Inventory and Appraisal."

5. GUARDIANSHIP OF ANTHONY H., CHARLIE H., AND LEVI H., 26PR0132**Petition to Appoint Guardian**

Victoria Hemenes (“petitioner”), the adult sibling of three minors — Anthony H. (age 12), Charlie H. (age 10), and Levi H. (age 9) — petitions the court to appoint her as guardian of the person. On May 22, 2026, the court appointed petitioner temporary guardian of the person.

On May 7, 2026, petitioner submitted a consent to appointment of guardian and waiver of notice that is signed by both of the minors’ parents and Anthony H., the only minor in this case over the age of 12.

To date, the court investigator’s report is not in the court’s file. (Prob. Code, § 1513, subd. (a).)
