Status of Administration

On July 12, 2024, the parties stipulated to stay this probate action pending the disposition of the related civil action in El Dorado Superior Court Case Number 24CV0833. In that case, trial is currently set for November 30, 2026. The court, on its own motion, and in the interest of judicial economy, continues the instant probate matter to December 4, 2026.
