#### 1. CONSERVATORSHIP OF BRIDGETTE B., SP20020052

#### Petition to Terminate Conservatorship of the Estate Only

On August 13, 2025, appointed counsel for the conservatee filed a petition to terminate the conservatorship of the estate, only, on the grounds that the conservatee is able to manage her finances and is frustrated by the restricted access to her funds. (Petn., ¶ 4.) "Unless the court determines, on the record and by clear and convincing evidence, that (1) the conservatee still meets the criteria for appointment of a conservator... of the estate under Probate Code section 1801, subdivision (b)...; and (2) a conservatorship remains the least restrictive alternative needed for the conservatee's protection, as required by subdivision (b) of Section 1800.3, the court shall enter judgment terminating the conservatorship." (Prob. Code, § 1863, subd. (c).)

This matter has been continued a few times at the request of appointed counsel for the conservatee. Counsel for the Public Guardian has informed the court they intend to contest the petition for termination at the continued hearing.
