#### 1. CONSERVATORSHIP OF BRIDGETTE B., SP20020052

#### Petition to Terminate Conservatorship of the Estate Only

On August 13, 2025, appointed counsel for the conservatee filed a petition to terminate the conservatorship of the estate only on the grounds that the conservatee is able to manage her finances and is frustrated by the restricted access to her funds. (Petn., ¶ 4.) "Unless the court determines, on the record and by clear and convincing evidence, that (1) the conservatee still meets the criteria for appointment of a conservator... of the estate under Probate Code section 1801, subdivision (b)...; and (2) a conservatorship remains the least restrictive alternative needed for the conservatee's protection, as required by subdivision (b) of Section 1800.3, the court shall enter iudgment terminating the conservatorship." (Prob. Code, § 1863, subd. (c).)

On September 12, 2025, the court granted a continuance to October 3, 2025, because the conservatee was undergoing a medical procedure. Counsel for the Public Guardian informed the court they intend to contest the petition for termination at the continued hearing.

## **Hearing Re: Status of Conservatorship**

The conservatee passed away on January 30, 2025. Therefore, the conservatorship has terminated by operation of law. (Prob. Code, § 1860.)

On August 1, 2025, the court allowed, approved, and settled the Twelfth and Thirteenth and Final Accounting. To date, there is no ex parte petition for final discharge (Judicial Council Form DE-295) in the court's file.

#### 5. ESTATE OF HAMM, 24PR0225

## Petition to Approve First and Final Account and for Final Distribution

Having read and considered the petition and supporting papers, the court requires additional information regarding certain disbursements (e.g., food and travel costs, and cash withdrawals) and reimbursement requests.

The petition seeks reimbursement for costs advanced by the administrator in the amount of \$1,715.68. The court notes that \$920.31 was incurred on June 18, 2025 (over a year following the decedent's death) for "celebration" expenses. Additionally, it appears the administrator advanced \$2,000.00 in attorney fees; however, there is no request for reimbursement of that amount.

Lastly, the petition alleges the administrator (Michelle Freeman) and Susan McDonough prepaid the specific gifts in the decedent's will to Steven Pion and Danny Gregory out of their personal funds. However, the court does is unable to locate these payments reflected in the accounting; there are merely signed receipts of distribution from Mr. Pion and Mr. Gregory for \$10,000 each.
