

1. GUARDIANSHIP OF ARMAGAN A., 25PR0194**Petition to Appoint Guardian**

The older brother of the proposed ward petitions to be appointed guardian of the person, and also requests Special Immigrant Juvenile ("SIJ") findings on behalf of the proposed ward.

Proof of service submitted July 22, 2025, shows that these filings were served upon the petitioner and the proposed ward. On August 25, 2025, petitioner submitted declarations from the proposed ward's mother and father consenting to the proposed guardianship and waiving notice in this matter. The petitioner also submitted declarations from the maternal grandmother and grandfather waiving notice in this matter. The paternal grandparents are deceased. The court finds that petitioner has satisfied the notice provisions under Probate Code section 1511.

The court investigator's report filed on August 25, 2025, recommends that both the guardianship petition and the request for SIJ findings be granted.

A Live Scan report was received on August 21, 2025.

Status of Administration

Letters Testamentary were issued on November 17, 2023. The Final Inventory and Appraisal was filed on March 18, 2024.

At the last hearing on July 25, 2025, the court granted counsel's request for a further continuance to complete preparation of the petition for final distribution. To date, said petition is not in the court's file.

3. MATTER OF THE SARE FAMILY LIVING TRUST DATED MARCH 12, 2018, 25PR0096**Amended Petition to Confirm Trust Assets and for Instructions (See Related Item No. 5)**

On July 2, 2025, the court sustained respondent Suzanna Krzaczek's ("respondent") demurrer to petitioner Stacy Hembree's ("petitioner") *Heggstad*¹ petition filed on April 17, 2025, with leave to file an amended petition on or before August 1, 2025.

On August 1, 2025, petitioner filed a timely amended petition, which is currently before the court. No opposition to the amended petition has been filed.

Paragraph 55 of the amended petition lists the names of persons entitled to notice of the hearing under Probate Code sections 851 and 17203, to include: petitioner, respondent, Brynna Hembree, Lanye Hembree, Jake Krzaczek, and the attorneys for respondent. To date, there is no proof of service in the court's file showing that the amended petition was served upon Brynna Hembree, Lanye Hembree, or Jake Krzaczek, who are each contingent beneficiaries under the Carole Marie Sare 2013 Trust. (Prob. Code, §§ 851, subd. (a)(2), 17203, subd. (a)(2).)

FUTURE REVIEW HEARINGS WILL NOW OCCUR BIENNIALY (EVERY TWO YEARS). THE COURT SETS THE NEXT REVIEW OF CONSERVATORSHIP AT 8:30 A.M., FRIDAY, SEPTEMBER 3, 2027, IN DEPARTMENT FOUR.
