

**1. GUARDIANSHIP OF ADDISON T. PP20160095  
ANNUAL STATUS REVIEW**

Guardianship of the minors was established on August 24, 2016. The annual guardianship status reports (Judicial Council Form GC-251) were filed by the guardian on 8/8/23. Having read and considered the reports, the court finds the guardianship remains necessary and shall continue.

PETITION TO APPOINT GUARDIAN**

A petition to appoint a guardian for Caleb was filed on 6/27/23. On 7/5/23 the court granted the temporary guardianship and dispensed with notice to the mother for the purpose of the Petition for Temporary Guardianship. The mother signed the Consent to Guardianship (Judicial Council Form GC-211) on 6/28/23. The court has no proof of service or declaration of due diligence regarding the father, paternal grandparents, or maternal grandfather. The petition notes that the maternal grandmother is deceased. Additionally, the court has not received the results from the Department of Justice.

APPOINT GUARDIAN**

A petition to appoint a guardian for the minors was filed on 6/27/23. Temporary guardianship was granted to Valerie Gerrard on 6/28/23. On July 7, 2023 a petition to terminate parental rights was filed in case number 23FL0625. Under Family Code 7806(b) all proceedings affecting the child, including proceedings under the probate code, shall be stayed on the filing of such a petition. As such, the court can take no action on the petition to appoint a guardian.
