**7. GUARDIANSHIP OF KELLY L. 23PR0038****Petition to Appoint Guardian**

A petition to appoint a guardian for Kelly was filed on 2/22/23. On 6/28/23 the mother appeared and provided previously unavailable identifying information for the paternal grandfather, Darryl Hand. The court had previously excused notice to the paternal grandfather on 2/22/23 based on lack of identifying information. However, the court directed that petitioner to make further attempts to notice the paternal grandfather based on the new information 6/28/23.

Additionally, mother stated she is opposed to the appointment of the proposed guardian at the hearing on 6/28/23. The proposed guardian indicated that mother's parental rights were terminated in a proceeding in the state of Utah. In response, a request for judicial notice was filed by the proposed guardian asking the court to take notice of permanent guardianship which was established appointing Julie and Chris Graham as guardians of Kelly, in the state of Utah. The order does not reflect a finding that the parents' parental rights were terminated in that proceeding.

The court has not received any further documentation of attempts to locate or serve the paternal grandfather.
