4. GUARDIANSHIP OF ADAN AND AIDA M. 22PR0072

Declarations of due diligence were filed regarding the mother, Caitlin Cokosky, the unknown father, unknown paternal grandfather, and unknown paternal grandmother on 6/7/23. The probate investigator's report was filed with the court on 7/7/23. The results of the Department of Justice criminal background check were filed with the court on 9/6/23. A notice of hearing was filed on 7/13/23 with proof of service to both parents and the maternal grandfather, Darrell Pingree. A declaration of due diligence was filed as to the maternal grandmother, Tracey Daniel, on 6/20/23. Both paternal grandparents are deceased. The court finds that notice was given as required by law.

The probate investigator report was filed on 7/27/23 recommending that guardianship of the wards be established, and that Shannon and Charity Nielson be appointed guardians of the person. Results of a criminal background check have been received by the court and neither proposed guardian has any criminal history.
