4. GUARDIANSHIP OF ALEXANDER C. 23PR0144

APPOINT GUARDIAN

A petition to appoint a guardian for Alexander was filed on 7/7/23. The court granted a temporary guardianship and letters were issued on 7/12/23. Proof of service by mail was filed with the court for Katherine Maes, Justin Lister, and Kristina Davies who are the surviving grandparents of the minor. The paternal grandfather is deceased. Both parents appeared at the hearing on 8/23/23 and stated on the record they do not object to the appointment of the guardians. The court has received and reviewed the probate investigator's report and the results from the Department of Justice background check. The court finds that notice has been given as required by law. Guardianship is necessary and appropriate for the minor.

The proposed guardian filed a proof of service that notice was provided to the parents via text message. As the court indicated previously, the parents must be noticed by personal service of the petition and supporting documents at least five days prior to the hearing.

The court granted the request and set the hearing on 9/6/23. The court does not have any notice of hearings filed for the permanent hearing for either 9/6/23 or 9/13/23 to parties entitled to notice. (Parents, grandparents, siblings over the age of 12). Additionally, the court has not received results from the Department of Justice. The court continues the matter for receipt of live scan results and for notice to all parties as required by law.
