Letters of Guardianship of the person were issued on 2/1/21 appointing Susan and Grondahl and Klint Young guardians of Steven. On 2/18/25 Dawn Luddy filed a petition requesting an appointment as co-guardian with Susan Grondahl. The petition indicates the Klint Young has passed away and that Ms. Grondahl needs assistance with providing day-to-day care of Steven. Steven has been residing with the proposed guardian and her husband since December of 2023. The current guardians and the minor's adult sibling Kaylee both signed a consent to appointment of guardian form on 1/17/25. The minor's mother was substitute served with notice of the petition on 3/1/25. The minor's grandfather was served by mail on 2/26/25. The minor's father is deceased. The court has reviewed the probate investigator's report filed 6/13/25. The recommendation is to grant the petition for guardianship. The court has not received results from the criminal background check.
