RESTRAINING ORDER MODIFICATION - REQUEST TO END / CHANGE**

A petition to appoint a guardian and temporary guardians was filed on 8/28/25. The court appointed Joy and Peter Cavaghan temporary guardians on 9/17/25. Father appeared at the hearing and acknowledged notice of the Petition. The mother is deceased and Petitioners are the maternal grandparents. Notice has not been provided to the paternal grandparents nor does the petition address whether there are any siblings over the age of 12 entitled to notice. The probate investigator recommends guardianship be granted. The father is opposed to the petition. The court will hear arguments from the parties; however, the court is inclined to maintain the temporary guardianship but not inclined to grant the petition. The court intends to order reunification therapy with the father, as was previously ordered, after consideration of input from the child's therapist on how best to move forward if available. The court is inclined to end the restraining order as it does not appear there is any reasonable basis to find it is needed for the protection of the only surviving protected party.
