

**1. Guardianship of Dillen M. 26PR0035
PETITION TO APPOINT GUARDIAN**

Petition to Appoint Temporary Guardian and Guardian were filed on February 17, 2026. At the March 4, 2026 hearing regarding the Petition to Appoint a Temporary Guardianship, the court dispensed with notice to the mother but found that notice was not properly given to the father nor to the minor. The Court continued the matter to April 15, 2026 and directed the proposed guardian to provide notice to all individuals entitled to notice by law. The Court also found that ICWA applies and directed the proposed guardian to notice the Cherokee Nation of Oklahoma, which it does not appear has been done yet. The Court reviewed the investigator's report which recommends against granting the guardianship.

PETITION TO TERMINATE GUARDIANSHIP**

Letters of Guardianship of the person were issued on May 29, 2019. On February 4, 2026, mother filed a Petition for Termination of Guardianship, to which the guardians and minor have given their consent. The court has reviewed the investigator's report which recommends that the petition be granted. The Court finds that termination of the guardianship appears appropriate but orders appearances to consider whether the court should make orders to ensure a smooth transition for the minor.

Upon review of the file, the court finds that the guardian still has not filed the Annual Guardianship Status Reports or an accounting.
