The court applies a clear and convincing evidence standard of proof to its determination of whether or not it appears necessary or convenient to appoint a guardian, whether or not granting custody to a parent would be detrimental to the child, and whether or not granting custody to the nonparent is required to serve the best interests of the child. (*Guardianship of Jenna G.* (1998) 63 Cal.App.4th 387, 394.)

Petitioners filed the mandated (1) Child Information Attachment forms for the Probate Guardianship petition (Form GC-210(CA)); (2) Duties of Guardian and Acknowledgment of Receipt form (Form GC-248); (3) Confidential Guardian Screening Form (Form GC-212); (4) Declaration Under UCCJEA (Form FL-105/GC120); and (5) Consent of Proposed Guardian (Form GC-211).

Notice

There is no proof of service in the court's file establishing that the mother and father were personally served with the notice of hearing and a copy of the petition. (Prob. Code, § 1511(b).) In petitioners' declaration of notice of ex parte application (filed Dec. 2, 2022), they state that the mother asked them to take custody of the proposed wards on September 29, 2022. Attached to the application is a handwritten letter from the mother stating that she consents to petitioners serving as guardians.

Petitioners further state that the father's whereabouts are unknown. However, petitioners have not provided any information by declaration from which the court can determine whether or not service of the notice of hearing and a copy of the petition should

be dispensed with because the father cannot with reasonable diligence be given notice, or the giving of notice would be contrary to the interest of justice. (Prob. Code § 1511(g); Cal. Rules of Ct., rule 7.52.)

The proposed wards' maternal and paternal grandparents are deceased. (Prob. Code, § 1511(c).)
