Petitioners' Motion to Compel Further Responses to Form Interrogatories

Petitioners' motion is denied without prejudice on the basis that the motion fails to comply with California Rules of Court, rule 3.1345. "[A]ny *motion* involving the content of a discovery request or the responses to such a request *must be accompanied by a separate statement*." (Cal. Rules of Ct., rule 3.1345(a) [emphasis added].)

Petitioners did not file a separate statement with their motion as required by rule 3.1345(a), but instead filed it with their reply, which raises a due process issue because respondents were deprived of the opportunity to respond to the separate statement.

Because petitioners made an unsuccessful motion to compel a further response, and the court does not find that petitioners acted with substantial justification or sanctions are unjust, the court finds that \$500.00 is a reasonable sanction under the Discovery Act. (Code Civ. Proc., § 2030.300(d).)

Respondent's Motion for Attorney Fees and Costs

On December 21, 2022, the court granted respondent's Motion to Quash Deposition Subpoena for Production of Business Records. Because counsel for respondent did not submit a declaration in support of his request for attorney fees and costs, the court denied the request without prejudice. Pending is respondent's motion for attorney fees and costs for having prevailed on the motion to quash. (Code Civ. Proc., § 1987.1.)

"[I]n making an order pursuant to motion made under ... Section 1987.1, the court may in its discretion award the amount of the reasonable expenses incurred in making or opposing the motion, including reasonable attorney's fees, if the court finds the motion was made or opposed in bad faith or without substantial justification or that one or more of the requirements of the subpoena was oppressive." (Code Civ. Proc., § 1987.2(a).) "'Substantial justification' means 'that a justification is clearly reasonable because it is well grounded in both law and fact. [Citations.]' [Citation.]" (Vasquez v. Cal. School of Culinary Arts, Inc. (2014) 230 Cal.App.4th 35, 40.)

The court finds that petitioner's opposition to respondent's motion to quash was without substantial justification and that sanctions are appropriate under the circumstances. (Code Civ. Proc., § 1987.2(a).) Having reviewed and considered respondent's counsel's declaration and the moving papers, the court finds that \$3,710.00 (10 hrs. x \$365/hr. + \$60 filing fee) is a reasonable sanction. Accordingly, the motion for attorney fees and costs is granted in part.

TENTATIVE RULING # 9: RESPONDENT'S MOTION FOR ATTORNEY FEES AND COSTS IS GRANTED IN PART. PETITIONER MUST PAY RESPONDENT'S COUNSEL \$3,710.00 NO LATER THAN MARCH 1, 2023.
