## 1. CONSERVATORSHIP OF DENNIS L., SP20160012

Biennial Review of the Conservatorship of the Person

#### 2. ESTATE OF IDELL, 23PR0077

#### **Petition to Administer Estate**

Petitioner is a creditor of decedent, who died intestate on July 20, 2022. Petitioner has a pending civil action against decedent's estate for property damage and personal injury to petitioner. Petitioner states that the spouse of decedent is aware of petitioner's creditor's claim and has refused to commence a probate action to resolve the pending lawsuit against the estate.

Petitioner seeks limited authority to administer the estate under the IAEA. She requests that bond be set at \$10,000, although the estimated value of the estate assets is \$255,000.

Decedent's spouse and unknown children and/or any next of kin were served by mail with the notice of hearing on April 25, 2023. The notice does not indicate that a copy of the petition was served along with the notice.

To date, Proof of Publication is not in the court's file. Petitioner also needs to file the mandatory Duties and Liabilities of Personal Representative (Judicial Council Form DE-147). Additionally, the Local Rules also require that petitioner submit the Confidential Supplement to Duties and Liabilities of Personal Representative (Judicial Council Form DE-147S). (El Dorado County Superior Court Local Rules, Rule 10.02.10.)

#### (2) Trial Re-setting

On March 21, 2023, the personal representative filed Judicial Council form DE-115, which is entitled Notice of Hearing on Petition to Determine Claim to Real Property. But, the personal representative did not file an actual petition. On March 29, 2023, respondent filed an opposition and moved to strike the form as procedurally improper.

The court agrees with respondent that the petition, in the form of a notice of hearing, is procedurally improper. "The court may, upon a motion [to strike] ..., or at any time in its discretion ... [¶] ... [s]trike out all or any part of any pleading not drawn or filed in conformity with the laws of this state, a court rule, or an order of the court. (Code Civ. Proc., § 436, subd. (a).) Accordingly, petitioner's form DE-115, filed March 21, 2023, is stricken from the court record.

On April 3, 2023, the personal representative filed a Petition to Determine Claim to Real Property pursuant to Probate Code section 850. The notice of hearing is attached to the petition and was not filed separately. Decedent's heirs were served by mail with the petition on April 3, 2023.

Petitioner alleges that the subject properties were purchased with decedent's money and title was placed in respondent's name, but that title was to be returned to decedent's name or under a family trust.

Although, to date, there are no oppositions or objections to the petition in the court's file, an objection can be made at any time, even orally at the hearing. (Prob. Code, § 1043.) Therefore, appearances are required.
