(*Guardianship of Jenna G.* (1998) 63 Cal.App.4th 387, 394.)

Notice

The proposed ward and her parents completed and signed item number 4 to Judicial Council form GC-211, stating that they consent to the appointment of a guardian and waiving further notice.

The Child Information Attachment states that the proposed wards' grandparents are all deceased. (See Prob. Code § 1511(c).) There is no proof of service of the notice of hearing and a copy of the petition on the proposed ward's siblings (if age 12 or older). (*Ibid.*)
