

**1. ESTATE OF MARTIN PP-20190142**

**Status of Administration**

The order of final distribution was entered on October 26, 2022. Upon review of the file, there are no receipts of final distribution nor Ex Parte Petition for Final Discharge (Judicial Council Form DE-295).

The court notes that it inadvertently set Status of Administration hearings on January 18, 2023 and February 6, 2023. The court vacates the February 6, 2023 hearing date.
