#### 1. WEBSTER v. WEBSTER 22PR0309

#### Petition to Compel Accounting by Attorney-in-Fact, Revoke Authority of Attorney-in-Fact

On November 29, 2022, petitioner Adrian L. Webster filed a petition to compel accounting by attorney-in-fact/respondent Timothy Webster, for a declaration that Timothy's authority as attorney-in-fact is revoked, and for attorney fees.<sup>1</sup> Adrian and Timothy are brothers. Their father, Adrian D. Webster ("father" or "principal") is the principal under a written durable power of attorney executed on February 28, 2019. (Pet., Ex. A.) The principal's spouse is deceased and he has not remarried.

The petition alleges: the principal resides at The Pavilion Memory Care and lacks the capacity to bring the petition or to give or revoke a power of attorney as he has been diagnosed with dementia; Timothy is using his father's assets for his own use and legal obligations and has sold his father's personal property and kept the proceeds for himself; he is using his father's automobiles while his father pays the auto loans of about \$2,000 per month; Timothy lives rent-free in his father's home and he does pay for any utilities, taxes, or insurance. (Pet.,  $\P$  7.)

Adrian has inquired about Timothy's management of their father's estate, but Timothy has been evasive and will not answer any questions. (<u>Ibid.</u>) On August 31, 2022, Adrian's attorney mailed a request for an accounting to Timothy. (<u>Id.</u>, Ex. B.) More than 60 days has elapsed and Timothy has not responded to the request or provided an accounting. (<u>Id.</u>, ¶ 10.)

The proof of service to the petition declares that the petition was served on Timothy and their father by mail on January 24, 2023. Although, to date, there are no oppositions or objections to the petition in the court's file, an objection can be made at any time, even orally at the hearing. (Prob. Code, § 1043.) Therefore, appearances are required.

### Petition to Admit Will to Probate (See Related Item No. 12)

This matter was continued from September 22, 2021, January 5, 2022, February 2, 2022, and March 9, 2022.

At the hearing on September 22, 2021, petitioners stated that the original will was in a safe deposit box that could not be accessed until letters were issued. In the related matter, <u>Estate of Robert Scott</u>, PP-20210149 (see item no. 12), an order for special administration was entered on July 12, 2022, to allow access to the safe deposit box. However, Letters of Special Administration were not submitted or issued. To date, Letters of Special Administration still have not been issued in that estate action.

At the time this tentative ruling was prepared, the original will still has not been lodged with the court.

In paragraph 22 of the petition, the personal representative states that the Franchise Tax Board ("FTB") presented a creditor's claim in the amount of \$20,653.38, but that she anticipated that the claim would be withdrawn by the FTB prior to this hearing. However, on January 6, 2023, the FTB filed an amended creditor's claim in the amount of \$24,115.77. To date, there is no evidence that the personal representative has either allowed or rejected the claim in whole or part. (Prob. Code, § 9250(a).) The court cannot consider the merits of the account and petition until the FTB's claim is resolved.

#### Letters of Special Administration with General Powers

#### Petition for Removal of Deceased Executor and Appointment of Successor Administrator

Pending is a petition for removal of the deceased executor and for the appointment of Eric Fleming, Jennifer Fleming's spouse, as successor administrator. The will of the decedent, Linda Gay Cox, nominates Jennifer Fleming as the executor and the Public Administrator as the successor executor. (Pet.,  $\P$  5.) Mr. Fleming contacted the Public Administrator about the will's designation, and the Public Administrator declined to act and executed a declination to serve as executor. (Pet.,  $\P$  7–8 & Ex. B.)

Petitioner is the spouse of the former executor, he is aware of the duties and actions that his wife performed as executor, and he is willing and able to act as the administrator. To date, there are no oppositions or objections to the petition in the court's file. All adult beneficiaries named in decedent's will have waived bond. Good cause appearing, and absent objection, the petition is granted.
