Regarding the Petition, the parties are ordered to appear to address the Court regarding status. Pending before the Court is also a Motion to Allow the Substitution of Successor in Interest, brought by Petitioner Donna Lee Abreu ("Donna").

On December 19, 2024, the Conservator, Donna commenced Petition 1. For Financial Elder Abuse; 2. For Order to Transfer Real Property to Conservator and Imposition of Constructive Trust, For Payment of Attorney's Fees, For Compensatory and Punitive Damages ("The Financial Elder Abuse Petition"). On May 15, 2025, the Conservatee Barbara Jean York-Norderhaug ("Barbara") died. The Petition named Mary Denise Bond and Thomas Bond Respondents and seeks the recovery of assets taken from Barbara and to impose a constructive trust over the real property at 5055 Arlington that Respondents fraudulently took from Barbara, and the recovery of compensatory and punitive damages and attorney fees from Respondents.

Donna argues she is the successor in interest because she is a named beneficiary of the residue of Barbara's Trust and the heir at law. There are no assets in the Conservatee's Trust or Estate, there is no probate of Decedent's estate pending and there is no Personal Representative of Decedent's estate, and the only other beneficiary and heir at law of Decedent is the Respondent Mary Denise Bond.

Respondents oppose the merits of the litigation but admit that a successor in interest is permitted to substitute. Respondents argue that Donna's claim involves an asset of a decedent and is subject to formal probate administration. The Court agrees.

Petitioner, JOANNA M. FULLER, ("Petitioner" or "Trustee"), sister of James Hugh Miller, Jr. ("James" or "Decedent") and Trustee of the James Hugh Miller, Jr. Trust, who died testate on December 24, 2021, brings this Petition pursuant to Probate Code § 17200 seeking to change venue. Cathy Hughes, ("Cathy" or "Respondent" or "Hughes") is one of the beneficiaries of the Trust.

Respondent filed a Petition in El Dorado County for Order Compelling Trustee to Distribute Remaining Trust Assets; To Compel Trustee to Account; Prohibiting Trustee from Using Trust Assets to Defend Action; For Relief from Breach of Fiduciary Duty; and for Surcharge.

Petitioner requests a change of venue to the Superior Court of Santa Clara County, because that is the principal place of administration of the Trust. While Decedent and Respondent lived in a home in El Dorado County which is a trust asset, the Trustee lives in San Jose, which is where the day-to-day activity of the trust administration is occurring.

Probate Code § 17005 (a)(1) states: "The proper county for commencement of a proceeding pursuant to this division is... in the case of a living trust, the county where the principal place of administration of the trust is located." The Court has also held that when the internal affairs of a trust are at issue, then the principal place of administration is the proper venue. *Capra v. Capra* (2020) 58 Cal.App.5th 1072.

Based on these facts, Santa Clara County has jurisdiction over this matter.

The Sally Arnold Caruso Trust ("Trust") was established in 1991. Following the settlor's death in 2004 the estate of the settlor was maintained in trust for the benefit of her son, Richard E.
