Petitioner requests the court to set aside the grant deed transferring title to the property and to determine that title belongs with decedent's estate, pursuant to Probate Code § 850. This request is based on decedent's lack of capacity to execute the deed, the exertion of undue influence by Respondent.

A proof of service of the Petition was filed, but only names sibling and Respondent Tammy Diaz, it does not include the third sibling, who was noticed of the Petition for Letters but not noticed of the instant Petition to determine title to the real property.

Petitioner further alleges:

- Mismanagement of Trust assets resulting in Over 30 municipal liens totaling more than \$10,000 due to neglect since 2021, utility shut offs, deferred maintenance, vacancies, unpaid taxes, and habitability/code violations affecting all trust properties.
- Irregularities in Pollock Pines property title; "Respondent self-designates as "Executor of Eugenia Wood" without appointment; evidence of owner-financing and forgery." Petition at 3:2-3.
- Concealment of settlor's death from mortgage lenders.
- No accounting or distribution of rental income from four income-producing properties.

Petitioner requests the following relief:

- Immediate suspension/removal of Anastasia "Tess" Wood as Trustee;
- Appointment of John DePiazza, professional fiduciary, as successor trustee;
- Order compelling full accounting from October 9, 2018 to present;
- Order directing Respondent to provide all Trust and financial documents;
- Surcharge of\$1,800,000-\$2,600,000 for misappropriated rental income plus \$10,000 penalties and additional depreciation/vacancy losses, to be proved;
- Legal interest pursuant to Probate Code§ 16440 on all sums;
- Restitution and damages for misappropriation/waste;
- Attorney's fees/costs per Probate Code §17211;
- Consideration of disinheritance under Probate Code §259, if further supported.

Other pleadings filed with the Petition include the Supplemental Declaration of Michael Hackerd in Support of Petition, dated December 11, 2025, which describes and attaches documentation of notices of violations from the City of Santa Cruz Planning Department listing code violations associated with one of the Trust properties.

Request for Judicial Notice
